The Committee of Adjustment for the Town of St. Marys will hold a public hearing on **Wednesday, April 20, 2022** at 6.00 p.m. to hear an Application for Consent under Sections 50(1) and 53 of the Planning Act, R.S.O. 1990 and you are invited to attend.

PLEASE NOTE that due to the COVID-19 pandemic state of emergency, all Committee of Adjustment meetings will be held online, until further notice. As this will be an online meeting, there will be no physical in person attendance. Please refer to "[Part II: Public Input and Attending the Public Hearing](#)" section of this Notice for details on how to attend the online meeting and/or provide comments to the Town respecting this Application.

Part I: Application for Consent to Sever (B01-2022)

The Subject Property (known as 323 Elgin Street West) and the Benefitting Property (known as 331 Elgin Street West) front onto the north side of Elgin Street West, between Warner Street and Carrall Street, as shown on the General Location Map attached to this notice. The properties are designated Residential according to Schedule 'A' of the Town's Official Plan and zoned "Residential Zone Two (R2)", in the Zoning By-law Z1-1997, as amended.

The Owner of the Subject Property has applied for consent to sever a strip of land along the west part of the property, to be conveyed and added to the Benefitting Property, as shown on the marked-up Severance Sketch excerpt provided with this Notice and summarized in the following chart:

Part II: Providing Public Input and Attending the Public Hearing

Any person(s) wishing to support or oppose this Application is permitted to attend or may submit comments in writing to the Secretary-Treasurer of the Committee of Adjustment prior to the date and time of the hearing. If you wish to be notified of the decision of the Committee of Adjustment in respect of the proposed Minor Variance, you must make a written request to the Secretary-Treasurer (contact information provided in the page footer). This will entitle you to be advised of a possible Local Planning Appeal Tribunal Hearing. If you do not make a written submission prior to a decision, or make an oral submission at the Public Hearing, and subsequently submit an appeal of the decision, the Local Planning Appeal Tribunal may dismiss the appeal.

Please note: comments and opinion submitted on these matters, including the originator's name and address become part of the public record, may be viewed by the general public and may be published in a Planning Report and will be included in the Committee agenda and minutes.

There are multiple opportunities for public input as outlined below however, to ensure that your comments are clearly understood and received prior to the Committee considering the Application, you are strongly encouraged to submit comments prior to the Committee meeting even if you intend to attend the online meeting. **Oral or written submissions will be received at the Public Hearing. 
