### Description and Location of Subject Lands

The 0.25 hectare (0.62 acre) subject property has frontage onto Water Street South as shown on the General Location Map. The property is designated "Highway Commercial" in the Town of St. Marys Official Plan and is zoned "Highway Commercial (C3-8)" in the Town of St. Marys Zoning By-law Z1-1997, as amended.

### Purpose and Effect of Zoning By-law Amendment Application

The purpose and effect of the Zoning By-law Amendment Application is to amend the Town's Zoning By-law to add contractor's yard or shop and ancillary offices as permitted uses in the "Highway Commercial (C3-8) Zone".

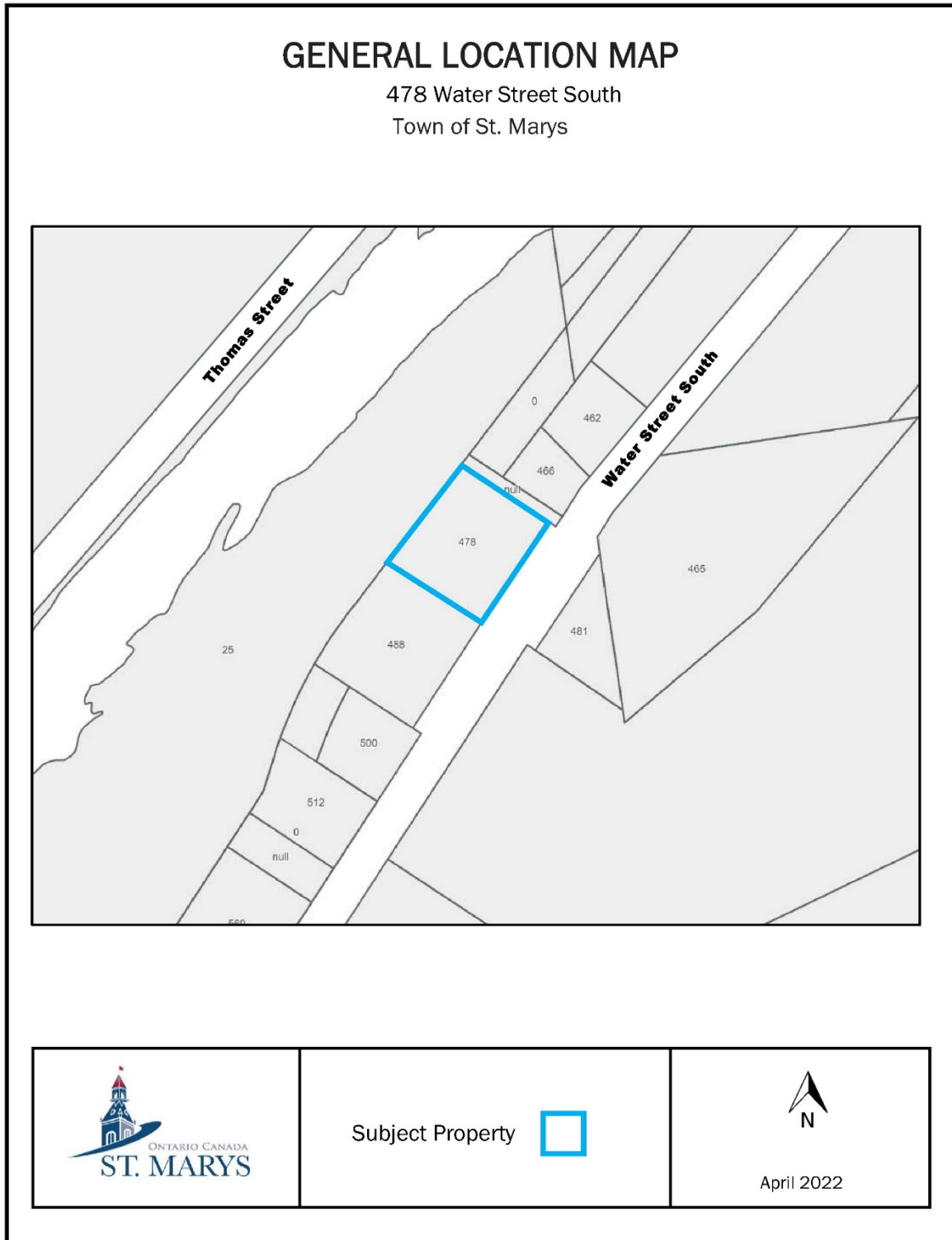
