## **BY-LAW 05-2023**

## THE CORPORATION OF THE TOWN OF ST. MARYS

Being a By-law to authorize an amendment to By-law 91-2022, being a by-law to establish fees or charges for services or activities provided or done by or on behalf of the Town of St. Marys.

provides that a municipal power shall be exercised by by-law;
